Wrangell St. Elias National Park and Preserve is accepting resume for **Full-Time Temporary Biological Science Technician position(s), GS-0404-04** . This announcement also is online at <https://www.nps.gov/wrst/getinvolved/employment.htm>. More than one position may be filled from this bulletin.

BENEFITS: Paid holidays, annual and sick leave. **FEHB Coverage:** Temporary, seasonal, and intermittent employees on appointments expected to last at least 90 days, and expected to work a schedule of 130 hours or more a calendar month, will be eligible to enroll in a Federal Employee Health Benefit (FEHB) health plan upon notification from their employing office. Eligible employees will be responsible for the employee share of the premium while on the official agency roles, which will be deducted from bi-weekly earnings.

APPOINTMENT INFORMATION: Temporary, Full-Time, approximately the mid May through the end of September. The appointment may be extended for an additional period (not to exceed 1039 hours total employment). Schedule may involve weekend work or performance of duties before or after "normal" working hours. Selectees may be moved between duty stations within park boundaries.

Government housing **may be available.**

Duties of this position will require:

The work is primarily at a remote site and may include weekend shifts with irregular hours. Exposure to biting insects is routine, with the possibility of encounters with potentially dangerous wildlife. You must be capable of walking up to five miles a day across wet, muddy, uneven terrain, lifting and carrying up to 50 pounds, and working in flowing, potentially hazardous water conditions. For all projects the incumbent will be responsible for following established safety procedures, maintaining a safe working environment, and providing input to improve the operation and performance of the project. Walking or riding/operating an off-road vehicle up to five miles a day across wet muddy terrain, and cleaning and repairing the weir in fast and potentially hazardous water conditions. Training will be provided for the operation of an ORV (Off Road Vehicle) and you must be capable of

safely operating the ORV for access to the remote work site. Work also might include sampling from boats and traveling by small fixed-wing aircraft or helicopter.

DUTIES: You will work as a Biological Technician for the Tanada Creek Salmon Weir project. Duties will include: installation, operation, maintenance, and removal of a floating picket fish weir, photovoltaic power system, and video equipment (underwater camera and recording system); enumerating sockeye and Chinook salmon passage and accurately recording data from the review of video recording; ensuring that the data is entered into an electronic spreadsheet on a daily basis; helping instruct new crew members about all aspects of work at the weir including safety issues; communicate work-related needs and problems that arise to supervisor in a timely manner; and provide information about the weir and weir data to visitors and guests. Record biological data of wildlife, birds and fish and enter it on a spreadsheet, monitoring bank erosion and inspecting for invasive plants, measuring water levels and temperatures though out the season.

Physical Demands: the work requires physical exertion such as regular and recurring walking, hiking or climbing over wet, rough, uneven or rocky surfaces; bending; crouching, stooping, lifting or reaching to observe, collect or record field data. Have items (e.g. equipment and packs up to 50 pounds) must be lifted and carried on a routine basis.

Work Environment: The work is performed in an office and in the field. Field work involves regular and recurring exposure to extreme weather conditions and terrain, poisonous plants, biting insects, and wild animals.

Qualification Requirements: Qualifications will be determined by evaluating your experience and/or education in your resume and/or transcripts submitted. All qualification requirements must be met by the closing date of this job posting. You must include the number of hours worked per week within your resume and submit a copy of your transcripts if qualifying with education. Unofficial transcripts are acceptable with your application, but official transcripts will be required if appointed to one of these positions.

To qualify for the GS-0404-04 Biological Science Technician position you must have one of the following qualifications:

A. You must have six months of general experience, and six months of specialized experience equivalent to the GS-3 level in the Federal service (obtained in either the public or private sectors), for a total of one year of experience. General Experience is (1) any type of work that demonstrates the applicant's ability to perform the work of the position, or (2) experience that provided a familiarity with the subject matter or processes of the broad subject area of the occupation such as assisting in the preparation of reports, utilizing computer programs to store and retrieve data, and providing information to others. Specialized Experience is experience such as working in a nursery that required the growing and maintenance of plants in a controlled environment; working in an environment comparable to a large farm where production records, animal environment, and sanitary conditions were kept in accordance with modern industry practice; taking and recording scientific measures; or assisting with research activities or field investigations related to the biological sciences. (I understand that excess Specialized Experience can substitute for General Experience; but excess General Experience cannot be substituted for required Specialized Experience). **(You must include the number of hours worked per week within your resume)**

OR

B. You must have successfully completed at least two years of education above high school (60 semester hour or 90 quarter hours) which included at least 12 semester hours in any combination of scientific or technical courses such as in biology, chemistry, statistics, entomology, animal husbandry, botany, physics, agriculture, or mathematics; at least 6 semester hours must be directly related to the position. **(You must include a copy of your transcripts)**

OR

C. You must have an equivalent combination of education and experience. To combine education and experience, first take the number of semester hours, and divide by 60. Take the number of months of full-time experience and divide by 12. Add the two percentages. The total must equal at least 100 percent. For example: I have 6 months of the general experience described above (50% of the experience requirement), plus 30 semester hours of undergraduate level work (50% of the education requirement) - which includes: at least 6 semester hours (50% of the courses as described above); of which, at least 3 semester hours of study must be directly related to the position (50% of the directly related study as described above). **(You must include the number of hours worked per week within your resume and a copy of your transcripts)**

In addition to the above qualifications requirements, your experience will be evaluated based on the following competencies. Please include your experience related to the competencies below within your resume.

- 1) Identify biological species of Alaska such as: salmon, trout, pike; otters, brown and black bear; invasive plants such as sweet clover.**
- 2) Collect and record biological and environmental data and provide findings to supervisor or higher-level specialist/technician.**
- 3) Utilize a digital video recording system and associated computer programs to review video recordings and accurately log biological data obtained for fish, wildlife, plants, water samples (streams, lake, rivers etc).**
- 4) Assist in using in-river structures and photographic equipment such as: photovoltaic poser systems, or video recording systems to monitor fish escapement.**

Volunteer Experience: Experience refers to paid and unpaid experience, including volunteer work done through National Service programs (e.g., Peace Corps, AmeriCorps) and other organizations (e.g., professional; philanthropic; religious; spiritual; community, student, social). Volunteer work helps build critical competencies, knowledge, and skills and can provide valuable training and experience that translates directly to paid employment. You are encouraged to include any volunteer experience within your resume.

CONDITIONS OF EMPLOYMENT:

- A background investigation must be completed and approved prior to employment.
 - Federal employees are required to utilize Direct Deposit (Electronic Funds Transfer/EFT), for their Federal Salary checks.
 - A valid state driver's license is required
 - Must be 18 years of age or older.

2. Veterans Preference documents, if claiming Veterans Preference (see below for documents)
3. Unofficial transcripts if qualifying with education.

VETERAN'S PREFERENCE (for qualifying veterans): To receive Veteran's Preference, your application package must include a copy of the DD-214, Military Discharge, that shows the type of discharge from service (usually the Member 4 copy), or Report of Separation from Active duty if separation was prior to July 1, 1979. If claiming 10-point veteran's preference, you must also provide a completed SF15 (www.opm.gov/forms) and verification documents listed on the SF15. If you are separated and do not have a DD214 yet you may use an official statement of service from your command that you have completed active service and are being discharged under honorable conditions, or provide other official documentation (e.g., documentation of receipt of a campaign badge or expeditionary medal) that proves your military service was performed under honorable conditions.
